NOTIFICATION

The Governor is pleased to accord approval for implementation of technology based **Bangla Shasya Bima (BSB) scheme** in West Bengal during Kharif 2020 season with Agriculture Insurance Company of India Ltd. (AICIL) as the implementing agency (IA). The scheme will be implemented considering **Gram Panchayat** level as the **Insurance Unit (IU)** in respect of **Aman Paddy** crop and **Block** level as IU for **Aus Paddy, Jute & Maize** crops. The cultivable land falling in Municipal Corporation/ Municipality/Urban areas where crop cultivation and insurance programme is operative will be tagged with the adjacent Gram Panchayat / Block as the case may be for crop insurance. The insurance scheme will be based on technology and shall leverage on a combination of satellite data, rainfall data and field level data generated for ground-truthing in order to lead to a faster and more objective assessment and settlement of crop insurance claims with the aim to support sustainable production in agriculture sector of the State of West Bengal by way of:

- i) Providing financial support to farmers suffering from crop loss/damage arising out of unforeseen events by fully subsidising insurance premium.
- ii) Ensuring coverage of all farmers including sharecroppers and tenant farmers growing the notified crops in the notified areas and having insurable interest.
- iii) Ensuring objective and fast settlement of claims using remote sensing and rainfall data, supplemented by field data collection and objective and transparent ground-truthing process.
- iv) Rationalization of the claims assessment procedure and actuarial pricing of the product.

The Revised Operational Guidelines for implementation of the technology based BSB scheme is given in **Annexure-IA**.

2. Crops and Insurance Unit:

The Scheme shall be implemented on an '**Area Approach basis**' for each notified crop with the assumption that all the insured farmers, in an IU face similar risk exposures, incur identical cost of production per hectare, earn comparable farm income per hectare, and experience similar extent of crop loss due to any insured peril in the notified area.

Four crops, viz, Aman Paddy, Aus Paddy, Maize and Jute will come under the technology based BSB scheme during Kharif 2020. The Insurance Unit (IU) in respect of Aman Paddy will be Gram Panchayat/ Municipality and for Aus Paddy, Jute & Maize crops the IU will be Block level.

The details of crop-wise notified areas are given in ANNEXURE – II to V.

3. Indemnity level:

The indemnity level for Aman Paddy and Jute will be 80% and that for Aus Paddy and Maize will be 90% in the notified area under the crop during Kharif 2020.

4. Coverage of farmers:

- 4.1 The enrolment of farmers will be through a **Master Policy** to be issued at the Block level in the name of the Assistant Director of Agriculture (ADA) of the block. The ADA of the block shall prepare the list of farmers crop-wise and insurance unit wise as per format in **Annexure XIII** and attach the same with the filled-in format of **Master Policy** as per **Annexure- XI** and forward the same to the AICIL for insurance coverage. Care should be taken to cover a particular farmer for a particular crop in any given IU, only once.
- 4.2 All the farmers who have been already enrolled either in BSB scheme during Kharif 2019 season or have been enrolled for **Krishak Bandhu (AI) scheme** should be automatically covered for crop insurance during Kharif 2020 season through the **Master Policy** under the scheme. They will not need to apply afresh.
- 4.3 The AICIL and ADA of the Block will undertake efforts to cover other willing and eligible farmers who are not covered in the above stated scheme mentioned in para 4.2. Such coverage should be done through **online mode** by using the **BSB App** with the help of local resource persons (LRPs) specially trained in usage of the **BSB App**.
- 4.4 All farmers covered under the scheme will be issued a “**Certificate of Insurance**” by the AICIL and the same will be reckoned as a proof of crop insurance and may be produced by the farmers to the Banks/ PACS, if required, for the purpose of sanction of crop loan.
- 4.5 The new farmers will have to produce documentary evidence regarding their insurable interest for insurance in cultivating land/crop (e.g. ownership/ tenancy/ cultivation rights) proposed for insurance and furnish the following documents/ details:
 - i) Name of notified Block/GP, Village and Mouza & JL No., Plot No. and crop wise cultivated **area (in acre)**.
 - ii) **KYC documents**- copy of current Voter ID Card (EPIC).
 - iii) **Bank Details**: Bank details of NEFT enabled bank account with a copy of pass book / Cancelled Cheque.
 - iv) For land owner: Copy of Khatian / Parcha / Patta / Deed.
 - v) **For Non-Owner Cultivator: Land Possession Certificate** for insurance coverage of non-owner cultivators (share cropper, tenant farmers, persons having land in the name of their father/grandfather etc.) will be issued by the concerned **Gram Panchayat Pradhan** in a

specified format (attached in **Annexure –X**). This document will be used only for crop insurance purpose during Kharif 2020 and not for any other purpose.

vi) **Area Sown Certificate**, if required, (actually sown or for intended sowing) will be issued by the Assistant Director of Agriculture of the concerned Block or his representative through **online mode in BSB Portal**.

5. Banks /PACS will not need to cover the loanee farmers during Kharif 2020 as most of farmers will be already covered in the **Master Policy** initiated by the ADA of the block. However, for farmers not covered under BSB scheme the concerned Bank/PACS may prepare a list as per format in **Annexure XIII** and forward the same to the concerned ADA within the cut-off date for insurance coverage.

6. **Clam assessment:**

6.1 Loss assessment will be made on the basis of **Crop Health Factor (CHF)** and payment of claims shall be settled in terms of **Revised Operational Guidelines** of BSB scheme as clarified in **Annexure-IA**.

6.2 **Crop Health Factor (CHF)** derived from the satellite data and rainfall / weather data will form the basis to arrive at the shortfall in expected yield for determination of season-end claims for each IU. The **Crop Health Factor** will be arrived based on the following parameters:

- i) **Crop Greenness** as measured by NDVI (Normalized Difference Vegetation Index).
- ii) **Crop Wetness** measured by LSWI (Land Surface Water Index) and
- iii) **Crop Structure** measured by **Backscatter Ratio (SAR)**:

$$\text{Claim payable} = \frac{(\text{Threshold CHF} - \text{CHF for the current year}) \times \text{Sum Insured}}{\text{Threshold CHF}}$$

6.3 The IA will reserve the right to repudiate any insurance proposal to avoid duplication of insurance against same piece of land.

8. The **entire share of premium** will be borne by the **State Govt.** for all notified Kharif crops (Aman Paddy, Aus Paddy, Jute & Maize) under Bangla Shasya Bima(BSB) scheme. However, a token amount of Rs.1/- (rupee one only) may be charged by the IA from farmers' bank account for

electronic updation of account details in the **State Crop Insurance Portal** to facilitate real time settlement of claim compensation.

9. The details of premium rate of crops for each district is given in **ANNEXURE –VI**.
10. The Sum Insured (SI) per hectare shall be same for all farmers and shall be equal to the **Scale of Finance (SOF) as mentioned in Annexure-IX**.
11. All claims will have to be borne by the AICIL. The claims will have to be settled within due date failing which penalty may be imposed as per provisions of BSB Operational Guidelines.
12. The AICIL shall make adequate publicity / awareness of the scheme in all the notified unit areas in coordination with State Govt. Electronic and print media may be utilized to create and disseminate awareness about benefits and provisions of the Scheme among the cultivators. The AICIL will work out appropriate plan in **consultation with the DDA(Admn)** of the districts for adequate awareness and publicity. The AICIL should get the publicity materials approved from the Agriculture Department before issuing them for publicity/awareness generation.

13. Monitoring and Supervision:

- 13.1 The State Level Monitoring Committee (SLMC), District Level Monitoring Committee (DLMC) and Block Level Monitoring Committee (BLMC) will be responsible for monitoring and supervision of the scheme at the respective levels.
- 13.2 **Grievance redressal:** At the initial level, grievance, if any, should be taken up for redressal at the Block level. The BLMC should respond to the grievances within 15 days of receipt of grievance. In case of dissatisfaction the matter may be referred to the higher level (BLMC to DLMC and DLMC to SLMC) for redressal of the issue.

14. The cut off dates for notified crops for Prevented Sowing / Prevented Germination district-wise and crop-wise and cut-off dates of harvesting of crops district-wise and crop-wise for all the notified districts in the state are given in **ANNEXURE- VII**.

The Block-wise list of notified Rain-Guage Stations / Automatic Weather Stations of the State Govt. that may be used as Reference Weather Stations (RWS) and Backup Weather Stations (BUWS) for determination of Observed Weather Index for assessment of payouts (claims) are furnished in **ANNEXURE-VIII**. In case of non-availability of weather data or data gaps, the data of adjoining weather stations or district IMD Stations may be used depending upon order of proximity.
