NOTIFICATION

Whereas it appears from the report prepared and submitted by the Deputy Director of Agriculture (Administration), Howrah, on the basis of Block level reports that out of the total 791 Mouzas of the District, standing crop on **763 (Seven Hundred and Sixty three) Mouzas** have been affected more than 33% of the crop coverage area as given in Annexure – A and out of total 157 (One Hundred Fifty Seven) Gram Panchayats of the District, standing crop on **142 (One hundred forty two) Gram Panchayats in total** have been affected more than 50% of the crop coverage area as given in Annexure – B in 14 (Fourteen) Blocks **due to Cyclone (AMPHAN) & Heavy rain on 20.05.2020.**

And whereas it appears from the above report of the Deputy Director of Agriculture (Administration), Howrah, that out of which total 791 Mouzas of the District, standing crop on **763 (Seven Hundred and Sixty three) Mouzas** have been adversely damaged more than 33% of the standing crop area as given in Annexure – A and out of total 157 (One Hundred Fifty Seven) Gram Panchayats of the District, standing crop on **142 (One hundred forty two) Gram Panchayats in total** have been adversely damaged more than 50% of the standing crop area as given in Annexure – B in 14 (Fourteen) Blocks **due to Cyclone (AMPHAN) & Heavy rain on 20.05.2020.** The damaged standing crop includes Boro Paddy, Vegetables, Groundnut, Sesame, S.Moong, Betelvine and other crops.

Therefore, I do hereby notify that total **763 (Seven Hundred and Sixty three) Mouzas** with more than 33% and **142 (One hundred forty two) Gram Panchayats in total** with more than 50% of standing crop area damage of 14 (Fourteen) Blocks as given in Annexure – B **due to Cyclone (AMPHAN) & Heavy rain on 20.05.2020**
