**Re: Minutes of the Steering Committee meeting on 29.02.2024**

The quarterly meeting of the Steering Sub-Committee of SLBC was held virtually on 29<sup>th</sup> February, 2024 to fix up the agenda for the ensuing 163<sup>rd</sup> SLBC meeting. The meeting was attended by Sri Partha Sarathi Dutta, Deputy Director, Institutional Finance, Finance Department, Govt of WB; Smt Joyoshi Das Gupta, Senior Special Secretary, ARD Department, Govt of WB; Sri Santanu Saha, Secretary, Fishery Department, Govt of WB; Sri R. K. Middya, Joint Director, MSME (PS), Govt of WB; Sri Sakshi Gopal Saha, State Head Project Monitoring Unit, West Bengal Bhabishyat Credit Card Scheme, Department of MSME, Govt of WB, Sri Sibabrata Pal, DGM, RBI; Sri Amlan Dash, DGM, NABARD, Sri Ajit Singh, AGM, NABARD and representatives of major member banks.

The Meeting began with a warm welcome note delivered by Sri Shio Shankar Singh, General Manager, SLBC West Bengal. He apprised the house that the 163<sup>rd</sup> SLBC Meeting for reviewing the business position ending on December' 2023 had been scheduled to be held on 08.03.2024. He briefly enumerated the proposed agenda items for the aforesaid SLBC meeting and invited the participants to give their valuable inputs/ suggestions for having a fruitful interaction on the proposed agenda points.
