### Re: Minutes of the Steering Committee meeting on 12.12.2023

The quarterly meeting of the Steering Sub-Committee of SLBC was held virtually on 12<sup>th</sup> December, 2023 to fix up the agenda for the ensuing 162<sup>nd</sup> SLBC meeting. The meeting was attended by Sri Manas Dhar, Special Secretary & Director, Institutional Finance, Finance Department, GoWB; Sri Sukanta Saha, Additional Director, ARD Department, Sri Santanu Saha, Senior Special Secretary, Fishery Department, GoWB; Sri R. K. Middy, Joint Director, MSME (PS), GoWB; Smt Arpita Biswas, GM, RBI; Sri Ajit Singh, AGM, NABARD and representatives of major member banks.

The Meeting began with a warm welcome note delivered by Sri Shio Shankar Singh, General Manager, SLBC West Bengal. He apprised the house that the 162<sup>nd</sup> SLBC Meeting for reviewing the business position ending on September' 2023 had been scheduled to be held on 20.12.2023. He briefly enumerated the proposed agenda items for the aforesaid SLBC meeting and invited the participants to give their valuable inputs/ suggestions for having a fruitful interaction on the proposed agenda points.

The major points of discussions along with the action points emerged during the Steering Committee Meeting are enumerated below:

- Sri Manas Dhar suggested to mention MJCC terminology for KCC-Fishery and KCC-AH for KCC Animal Husbandry in Agenda item.
- Sri M.Dhar also suggested to make a separate agenda for West Bengal Bhabisyat Credit Card (WBBCC) with title- Implementation and Progress made under WBBCCS.
- Smt Arpita Biswas, GM, RBI requested Institutional Finance to provide the latest status regarding Digitalisation of land records to SLBC for onward submission to RBI central office.
- Sri. Ajit Singh, AGM, NABARD, requested to add a new agenda item 'Agri Clinic & Agri Business' under Agriculture.
- Sri. Ajit Singh, AGM, NABARD, also requested to invite public representatives like MPs & MLAs in the DCC & DLRC Meetings.
- Sri M.Dhar requested Sri Ajit Singh to raise the issue during discussion of 162 nd SLBC meeting.
- All the points were noted by SLBC for ensuring compliance. Member banks also accepted the views/ suggestions emerged from the meeting.
