## The Members of the SLBC Steering Committee

## Re: Minutes of the Steering Committee meeting held on 14.12.2022

The quarterly meeting of the SLBC Steering Committee was held on 14<sup>th</sup> December, 2022 virtually to fix up the agendas for the ensuing 158<sup>th</sup> SLBC meeting. The meeting was attended by Sri Avanindra Singh, Secretary, Fisheries Department, GoWB; Sri Manas Dhar, Special Secretary & Director, Institutional Finance, Finance Department, GoWB; Sri. Prabir Roy, Additional Director, ARD Department, GoWB; Sri Sudip Mukherjee, Additional Director, Fisheries Department, GoWB; Sri Provin Kami, DGM, RBI; Sri Amit Kumar Das, DGM, NABARD; Sri Ajit Singh Jhakar, AGM, NABARD and representatives of major member Banks.

The Meeting began with a warm welcome note delivered by Sri Shio Shankar Singh, General Manager, SLBC West Bengal. He apprised the house that the 158<sup>th</sup> SLBC Meeting for reviewing the business position ending on September' 2022 had been scheduled to be held on 23.12.2022. He briefly enumerated the proposed agendas for the aforesaid SLBC meeting and invited the participants to give their valuable inputs/ suggestions for having a fruitful interaction on the proposed agenda points.

The major points of discussions along with the action points emerged during the Steering Committee Meeting are enumerated below:

- ➤ Sri Manas Dhar, Special Secretary & Director, Institutional Finance, Finance Department, GoWB discussed on the potentiality of KCC-AH and Fisheries and requested to include a sub-agenda on the Tie–ups with the Milk Unions.
- > Sri M. Dhar requested to include as a sub-agenda on Financial Literacy Camps in Animal Husbandry intensive area.
- ➤ Sri M. Dhar also discussed about the importance of promoting non-conventional renewable energy as sustainable alternative for affordable transportation. He requested to include a special agenda on the same in the 158<sup>th</sup> SLBC Meeting Agenda.
- Sri Amit Kumar Das, DGM, NABARD discussed regarding on boarding of Banks/ Eligible Lending Institution(ELI) for registration with NABSanrakshan for financing Farmer Producer Organisation under Credit Guarantee Scheme. Mr. M. Dhar has mentioned that it is already included in the agriculture agenda.
- Sri. Prabir Roy, Additional Director, ARD, GoWB pointed out that the data regarding KCC-AH derived from the portal as well as received from various fora had significant mismatch. He highlighted on the need of proper data synchronization. Sri Pravin Kami, DGM, RBI also affirmed the same. Mr. M. Dhar advised to include a sub-agenda on Data Management on KCC-AH in this regard.



> Sri Shio Shankar Singh, GM, SLBC requested all the member banks to raise any point to be included to which all member banks agreed to the Agenda.

All the points were noted by SLBC for ensuring compliance. Member banks also accepted the views/ suggestions emerged from the meeting that to be discussed in the ensuing 158th SLBC meeting.

After having fruitful interactions amongst the participants, the Final Agenda Items and its sequence as well were finalized for discussion in the ensuing 158<sup>th</sup> SLBC meeting and getting confirmation from the participants, Sri Shio Shankar Singh described the final agenda items as follows:
