Minutes of the SLBC Sub-Committee meeting on Agriculture for fixing Ceiling Price of Potato for FY 2022-23 held on 05.01.2023

A meeting to finalize the Ceiling Price of Potato for financing the cold storages for on-lending to the farmers as well as financing to the farmers was held at Suchintan (4th Floor), Punjab National Bank, Kolkata Zonal office on 05.01.2023 which was hosted by Sri Shio Shankar Singh, General Manager, SLBC West Bengal. The meeting was graced by Sri Hrishikesh Mudi, Special Secretary, Agriculture Department GoWB, Sri Ashoke Kumar Das. Special Secretary, Agricultural Marketing Department GoWB, Sri Manas Dhar, Special Secretary & Director, Institutional Finance, Finance Department GoWB, Sri Samrat Mukherjee, General Manager, NABARD, Sri Debojyoti Dutta, Assitant General Manager, RBI, representatives of the West Bengal Cold Storage Association and dignitaries of the member banks.

At the outset, Sri Shio Shankar Singh welcomed all the participants in the meeting and informed the house about the process of arriving at the price of potato considering various parameters related to pre-harvest & post-harvest costs involved in cultivation and storage. The house has been informed that data on the same were collected from 11 predominantly potato growing districts, viz. Murshidabad, Purulia, Purba Bardhaman, Birbhum, Hooghly, Paschim Medinipur, Bankura, Malda, Coochbihar, Alipurduar and Jhargram through the LDMs. The house was requested to take a consensus call on the same for arriving at a uniform price for the state under the prevailing market condition. Sri S. S Singh requested Sri Manas Dhar to preside over the meeting.

Sri Ashoke Kumar Das, Special Secretary, Agri Marketing Dept. GoWB apprised the house that during storing of potato in the month of March 2022, the rate was Rs.1200-1300/ quintal but after approx. 10 months market price became Rs.700-800/ quintal. In this connection he also informed the house that in other states there are different hiring charges in different districts for cold storages, whereas it is fixed by Agri. Marketing Dept. of GoWB at Rs.170/ quintal in North Bengal stand Rs.168/ quintal in rest part of our state. He also highlighted that the Agri. Marketing Department was in process of setting up an online platform for application and renewal of license for cold storage owners.

Sri Bidhayak Mukherjee informed the house that potato cultivable area was 4.47 lakh hectare where production of potato was 124 lakh MT resulting a productivity of 27.72 ton/ ha in last FY 2021-22. This year as per their advance estimation, production is going to be increased than previous year to the tune of 32 ton/ha productivity in total 5 lakh hectare cultivable area. He also expressed his concern regarding the foggy climatic situation prevailing in the eastern side of Burdwan district which may subsequently affect the production in due course.

The representatives of the West Bengal Cold Storage Association informed that due to adverse climatic condition in the last year there was a massive decrease in potato production leading to a severe loss for the cold storage owners but considering a favorable climatic condition till date he was very much optimistic over a huge production of potato in this FY 2022-23.



After a detailed discussion guided by Sri Manas Dhar and based on the inputs received from the participants, it was assessed that the average production cost per quintal would be around Rs.612/- and the cost of post-harvest expenses, cost of storage would be around Rs.269/- for the current year. The yield per acre was assumed at around 128 quintal (including non-sorted potatoes).

Based on the discussions, the House agreed for the following item wise average cost of production:

Sri Manas Dhar apprised the house that the aforesaid pricing exercise was based on certain assumptions depending upon the present climatic situation and the same would be subjected to revision according to the ground situation prevailing at the time of harvesting as well as storing which might have either positive or negative impact on the yield of potato and the information regarding prevailing ground situation will be provided to SLBC department by the Agriculture Marketing Department GoWB, if any. It was also agreed upon that in such a scenario, re-assessment of potato price, as fixed above, would be further examined and revised rationally by convening another meeting with the committee members and representatives of the West Bengal Cold Storage Association in due course of time.

The meeting was ended with vote of thanks to the chair & participants by Sri Shio Shankar Singh, General Manager, SLBC West Bengal.
