The Members of the SLBC Steering Committee

Re: Minutes of the Steering Committee meeting held on 17.03.2023

The quarterly meeting of the SLBC Steering Committee was held on 17.03.2023 virtually to fix up the agendas for the ensuing 159<sup>th</sup> SLBC meeting. The meeting was attended by Sri Manas Dhar, Special Secretary & Director, Institutional Finance, Finance Department, GoWB; Sri Sibabrata Pal, DGM, RBI; Smt. Deepmala Ghosh, GM, NABARD and representatives of line departments and major member Banks.

The Meeting began with a warm welcome note delivered by Sri Shio Shankar Singh, General Manager, SLBC West Bengal. He apprised the house that the 159th SLBC Meeting for reviewing the business position ending on December' 2022 had been scheduled to be held on 24.03.2023. He briefly enumerated the proposed agendas for the aforesaid SLBC meeting and apprised the house that 159th SLBC was going to be the Special SLBC meeting emphasizing the progress of Financial Inclusion and Financial Literacy in the state. He invited the participants to give their valuable inputs/ suggestions for having a fruitful interaction on the proposed agenda points.

The major points of discussions along with the action points emerged during the Steering Committee Meeting are enumerated below:

- Sri Sibabrata Pal, DGM, RBI briefed that SLBCs had to hold one of the regular quarterly meetings of SLBC/UTLBC as Special SLBC/ UTLBC meeting to review the progress of Financial Inclusion and Financial Literacy. Accordingly, one DCC meeting also be held as Special DCC meeting. Sri Manas Dhar, Special Secretary & Director, Institutional Finance, Finance Department, GoWB suggested for a single agenda on Progress under Financial Inclusion clubbing two agenda namely Special SLBC on Financial Inclusion and the regular agenda of financial inclusion. Since, this SLBC is going to be a Special SLBC on FI, this agenda should be specially focused and to come on top. Sri S. Pal accepted his proposal.
- Sri S. Pal also voiced for keeping an agenda for adoption of two new districts for converting those districts 100% digitally enabled. Sri M Dhar suggested for keeping it under the agenda of Expanding and Deepening of Digital Payment Ecosystem (Including Payment Banks etc.). Emphasizing the fact of Special SLBC on Financial Inclusion, he requested to keep this agenda after the agenda of Progress under Financial Inclusion. Sri S. Pal accepted his suggestion.
- Sri Manas Dhar requested for omitting the review of districts with CD Ratio below 40% along with corrective measures taken in Special Sub-Committees of the DCC (SCC), since all districts had surpassed the benchmark CD ratio of 40% and suggested for keeping a single agenda of CD Ratio of the State. Sri S. Pal, RBI and Sri S.S. Singh, General Manager, SLBC accepted his proposal.



- Acknowledging the fact that this SLBC is going to be a special SLBC on FI, Smt. Deepmala Ghosh, GM, NABARD requested SLBC for providing district wise banking outlet details, number of banking outlets per lakh population, District wise PMJDY progress etc. Sri S.S. Singh apprised the house that bank wise and district wise all these data would be available under the agenda of Progress under Financial Inclusion. Smt. D. Ghosh also requested for highlighting FIF scheme and NABSANRAKSHAN. Sri S.S. Singh apprised that FIF scheme is incorporated in Progress under FLC and NABSANRAKSHAN was also being enumerated under AIF scheme. Smt. D. Ghosh requested SLBC for exploring the possibility of proving district wise disbursement data under Other Priority Sector, which would help in formulation of PLP. Sri S.S. Singh noted the same.
- Ďr. Atanu Saha, Asst. Director, ARD Dept. requested for incorporating Animal Husbandry Infrastructure Development Fund and progress under AH FPOs as agenda. Considering, the importance, Sri M. Dhar requested to include Animal Husbandry Infrastructure Development Fund as a sub-agenda under Deployment of Credit in Agriculture. He also suggested for discussion of AH FPOs under the agenda of Review of credit deployment under FPO.
- ➢ Sri Sandip Nag, Joint Director, Textile Department requested for providing sanction and disbursement data under Weavers Credit Card. Sri S.S. Singh informed that WCC progress in terms of sanction as on 31.12.2022 had been incorporated under Review of Mudra (Including ACC & WCC). Since, WCC disbursement data is being collated w.e.f 31.01.2023, the same would be apprised during SLBC meeting.

Member banks also accepted the views/ suggestions emerged from the meeting that to be discussed in the ensuing 158th SLBC meeting.

After having fruitful interactions amongst the participants, the Final Agenda Items and its sequence as well were finalized for discussion in the ensuing 159th SLBC meeting and getting confirmation from the participants, Sri Shio Shankar Singh described the final agenda items as follows:
