SLBC has conducted the following meetings, mostly through Video Conference in June, 20 quarter.

04-05-2020	Special SLBC meeting chaired by Hon'ble Finance Minister
06-05-2020	Sub Committee meeting on MSME
11-05-2020	Sub Committee meeting on Horticulture & Food Processing Industries
13-05-2020	Sub Committee meeting on Agriculture (Animal Husbandry & Fishery)
03-06-2020	Sub Committee meeting on Digital Banking (by circulation)
04-06-2020	Sub Committee meeting on SHG

The minutes of the meetings and the action points have also been shared with the member banks/LDMs and uploaded in the SLBC website as well. SLBC has since taken up the matter regarding holding of the 149th SLBC meeting pertaining to the business position for the quarter ending on March, 20 with Govt of West Bengal authorities. It is expected that the meeting may be conducted in the last week of June, 2020 through VC by the Govt authorities with participation of the major banks & other stakeholders in the wake of COVID 19 pandemic related issues.

In view of the prevailing situation and social distancing norms, SLBC has since decided to proceed with the Steering Committee meeting with adoption of the following major resolutions by circulation.

- As decided in the 148th meeting, SLBC increases MSME target in FY 20-21 to Rs.90000 crore.
- District-wise targets have already been allocated as per specified sectors/sub-sectors by SLBC for allocation among the banks by LDMs through DCPs.
- LDMs will also allocate the targets to banks under schematic lending, e.g, KCC (crop loans and animal husbandry/fishery activities), NRLM, NULM, PMEGP, etc.
- SLBC has issued Advisory (No.104 dt 12-06-20) for coverage of landless farmers on the basis of Area Sown Certificate w.r.t. coverage of non-loanee farmers under KCC for which target is fixed at 20 lakhs under Kharif,2020. The prescribed SOP is to be followed for timely completion.
- SLBC has devised simplified Common Application Forms for animal husbandry schemes of dairy, poultry, goat/pig rearing as well as fisheries. ARD Deptt has also finalized the model scale of finance for the animal husbandry schemes. Banks are to utilize the forms and the SoF.



- The target for PoS enrolment (by 31-12-2020) for digital district of Nadia has been fixed at 2050
- The standardized data management system has been made operational. Member banks are to submit the data for March,20 quarter (on Text format) as parallel run will be made for the stated quarter. From June,2020, data submission on online basis through the system will be applicable.
- The agenda for the meeting as usual will be as per norms incorporating all the major parameters as prescribed by Reserve Bank of India.

We are now forwarding herewith the Flow of Events for 149th SLBC meeting along with the list of the agenda items for kind information/conformation of the members of the Steering Committee. Same will be shared with the member banks accordingly.
