Re: Minutes of the 147th SLBC, West Bengal meeting on 20-12-2019

The performance review meeting for Sept, 2019 quarter was held at 3.00 P.M on 20-12-2019 at Hotel Hindustan International, Kolkata under the joint Chairmanship of Dr Amit Mitra, Hon'ble Finance Minister of GoWB and Sri Ashok Kumar Pradhan, MD & CEO of United Bank of India. The list of the Dignitaries, Executives from Govt Departments, RBI, NABARD, Member Banks & Other Financial Institutes as well as LDMs, participating in the meeting is annexed.

The following are the observation emerging as Action Points during the review of the performance of the Banks in respect of different parameters under institutional credit in the State of West Bengal.

A) C D Ratio:

- Lowered to 62.18% against 63.12% as on 30th June and 64.57% as on 31st March. Although huge Govt Deposits attribute to such low CD ratio in these Districts, LDMs of 24 Paraganas (North), Hooghly and Paschim Burdwan to draw definite strategy for improving the CD Ratio which must be visible in the next quarter.
- Dr Mitra stressed on area wise study with analysis of the loan ticket size for profiling the credit needs in respective clusters. SBI LHO is to monitor the progress in Paschim Burdwan district. (Action Point 1:LDM of 24 PGS(N), Hooghly, Paschim Burdwan)

B) Agriculture Advances:

• Credit deploymentunder Agricultureonly 40% of the yearly target during the 1st half year. This is an area of concern.Banks were advised toproactively adopt the centres identified/ratified by SLBC & ARD Deptt (117 Dairy, 67 Poultry, 80 Goatery & 49 Piggery centres) for accelerated finance on camp mode with generation of proposals.

(Action Point 2: Member Banks)

The State is largest producer of vegetables and 2nd largest producer of fruits in the country.
Thus there is ample scope for Agro & Food Processing units in the State. MNCs like ITC,
Pepsico, IFBin setting up product sourcing centres may be involved. SLBC, NABARD and
Department of Food Processing & Horticulture to hold a special meeting for identification &
adoption of potential centres for focused credit linkage.

(Action Point 3: SLBC, NABARD & Line Deptts)

C) KCC Advances:

 Sri A K Pradhan exhorted the banks to bring the 33 lakh non-loanee farmers as enrolled in Bangla Shasya Bima Scheme under the ambit of KCC scheme which will ensure saturation of the program also.

(Action Point 4: Member Banks & Agri Deptt)



 The list of beneficiaries of Krishak Bandhu scheme should be collected by the Bank branches from the appropriate authorities to attain saturation of KCC. Officials of the concerned departments at Block and Panchayet level are also requested to co-operate in this regard in order to achieve the goal of KCC saturation.

(Action Point 5 : All Member Banks & Line Govt Department)

- Dr A Mitra pointed out that the coverage of allied activities and fishery activities under KCC scheme with provision for interest subvention is very much on the lower side and advised for targeting the eligible existing crop loan farmers for supplementary loans under AH & F schemeswhich will also result in diversification of business.
- Insurance Companies have been advised to arrange for insurance cover accordingly.
 (Action Point 6: SLBC, Member Banks, Insurance Cos, ARD Deptt & Fishery Deptt)

D) Crop Insurance, Krishak Bandhu Scheme& others:

 Issue of problems GoWB authorities will provide support to the farmers during the Kharif & Rabi seasons by way of cheques only under Krishak Bandhu scheme. These will be deposited in time for onward collection without delay/refusal by banks.

(Action Point 7: Member Banks)

Insurance Companies are to settle the claim at the earliest for crop damage in 2019
particularly for Hooghly, Purba Medinipur and Pachim Medinipur. Similarly, banks which are
to yet to submit the Utilization Certificate for previous 3 years claim settlement cases, must
comply with the same for closure of Insurance Audit works.

(Action Point 8 : Insurance Companies & Member Banks)

• Bankers to extend relief as per RBI norms to the eligible farmers affected by natural calamities as per notifications issued by Govt authorities from time to time.

(Action Point 9. Member Banks and LDMs)

E) MSME Advances:

- Achievement against the ACP is more than 50% (Rs.35089 crore against the target of Rs.75000 Cr.) as at the end of first half.
- Sri A K Pradhan advised the banks to take up the restructuring of MSME accounts on merit
 as per RBI norms.
 (Action Point 10 : Member Banks)
- SLBC efforts on cluster approach under which identification of borrowers and receipt of application by the sponsoring agencies have already kick-started should be taken to logical conclusion through sponsoring of all proposals followed by disposal of the same by the Banks.

(Action Point 11: All DICs in the clusters, KVIB, Handloom Deptt and Member Banks)

F) SHG Advances:

- Dr A Mitra advised the banks to reduce the gap between the sanction and disbursement in NRLM loans through full disbursement of the sanctioned limit at the earliest and also opined that the SHGs are encouraged for undertaking export oriented activities. (Action Point 12: Member Banks & WBSRLM)
- Ms C D Lama, SMD & CEO of WBSRLM opined that the banks should fix a particular day in a month for CBRM for effective recovery & monitoring of NRLM loans.

(Action Point 13: LDMs are advised to fix the date for respective districts)



G) NPA Recovery:

 Sri A K Pradhan requested the State Govt authorities for expediting the process of granting permission by District Magistrates in 2068 NPA accounts for Rs.1324 crore as conveyed by SLBC desk in order to enable the banks to take possession of the secured assets under the SARFAESI Act, 2002. (Action Point 15. Govt of West Bengal)

H) Other Credit Related items:

 Ms M Meena, Secy , Backward Class Welfare Deptt informed that till date 5000 loans sponsored by the Department under Special Component Plan (SCP) has been sanctioned as against 13000 in last year. Banks are to dispose of the pending proposals.

(Action Point 16: Member Banks)

 Dr P Mazumdar informed that out of 1380 Custom Hiring Centres, 147 Centres have been supported till date. However, it is reported that there is delay in disbursement and despite 40% Subsidy available under the scheme, some branches are insisting on 100% collaterals. The Deptt is also to furnish the district-wise list for increasing the credit flow to these Centres.

(Action Point 17: Member Banks & Line Department)

• Sri A K Pradhan also advised the banks to accelerate the credit to the RSETI trained entrepreneurs so that the settlement ratio improves from 70% to 90% by next fiscal.

(Action Point 18: RSETI Directors & Member Banks)

Action Fount to . NOL 11 Directors & Member Dani

- Sri S K Mondal, CGM of NABARD flagged off the following matters for the banks.
- i)Activation of Rupay KCC Cards
- ii) Implementation of E-Shakti program in 10 other districts
- iii) NABARD support for micro ATM
- iv) Disposal of Subsidy linked loans with claim for Subsidy
- v) Loans for bee keepers & Allocation of target by SLBC

(Action Point 19: NABARD/SLBC & Member Banks)

I) Digital District:

 Focus on digitization of the District of Nadia so that the concept of digital district is taken to the logical conclusion for the said district. Efforts should be taken to prevent entry of fraudsters.

(Action Point 20 : LDM & Member Banks of Nadia District)

J) Unbanked Rural Centres:

Member Banks to complete opening of Banking Outlets in the 40 URCs allocated to them
by the SLBC desk.
 (Action Point 21 : All the Allottee Member Banks)

K) Miscellaneous:

All other agenda as given in the agenda note, not mentioned above, were also discussed.
Although there is no specific direction from the concerned authorities towards the bankers,
proactive role of all the stakeholders is expected during the coming two quarters for allround development of the eco-system of the State.
