Re: Minutes of the SLBC Sub-Committee meeting on RSETI held on 30.06.2022.

The SLBC Sub-Committee meeting on RSETI was convened on 30.06.2022 to review the functioning & performance of the 19 RSETIs in the state as on 31.03.2022. The meeting was participated through VC by Sri Partha Sarathi Datta, Dy. Director, Institutional Finance, GoWB; Sri Sameer Majumdar, AGM, NABARD, Sri Ashish Agarwal, Manager, RBI; Sri Swapan Kr. Nandi, State Director for RSETIs; Sri Tulshi Lal Bhaduri, Consultant (Banking & FI), WBSRLM and representatives of member Banks.

Sri Shio Shankar Singh, General Manager, SLBC West Bengal, heartily welcomed all the participants in the meeting and requested Sri Swapan Kr. Nandi to preside over the meeting. The key issues discussed along with the action points emerged in the meeting are enumerated below:

1. Achievement under Annual Action Plan 2021-22:

Sri Swapan Kr. Nandi, SDR informed the house that initially cumulative AAP target for FY 2021-22 of 19 RSETIs was to conduct 428 no of training programmes covering 11695 no of candidates. Later, due to Covid-19 pandemic, the AAP target has been revised to 317 number of programmes covering 8655 candidates. As on 31.03.2022, all RSETIs have trained 9182 no of candidates conducting 339 no training programmes, thus achieving 107% & 106% of the revised AAP target in terms of no of programmes & no of trainees respectively.

Sri Shio Shankar Singh, GM, SLBC was delighted to note that cumulative Settlement & Credit linkage for RSETIs in the state of West Bengal stood at 73% & 61% respectively, which is quite satisfactory. However, he solicited for the further improvement in this regard.

2. Annual Action Plan 2022-23

Sri S. K. Nandi, SDR informed that AAP target for FY 2022-23 fixed for conducting 436 number of programmes covering 11820 candidates. Praising the cumulative effort, Sri S.S. Singh requested all member banks to advise the RSETI Directors to maintain same pace in current financial year to achieve the AAP target for FY 2022-23.

(Action point 1: All RSETIs)

3. Status of Land Allotment & construction of RSETI building as well:

Sri S.S. Singh noted that out of 19 RSETIs, only a few number of RSETIs are running from their own building. In majority of cases, land allotment is pending at the end of respective districts. Again land provided to some RSETIs have been encroached by some other people. In some RSETIs, land have been allotted by State Govt. but construction of building has not been started.



Sri S. K. Nandi narrated that allotment of land and construction of RSETI building is a very vital issue for running of RSETIs in the state of West Bengal. He highlighted that the issue of shifting of Darjeeling RSETI sponsored by Central Bank of India, as discussed in the previous sub-committee meetings, is still pending at district level. He requested WBSRLM to take up the matter with concerned District authority. Smt Binoti, Senior Manager, CBI also highlighted that Bank had requested Coochbehar District authority to evacuate the encroachment for several times, but positive response yet to receive. Sri T.L. Bhaduri requested member banks to take appropriate action for surrounding the land by a wall to minimize the possibility of encroachment of land and to start necessary construction work at the earliest.

Sri S. K. Nandi highlighted that construction of RSETI building in Uttar Dinajpur district had been pending since long and the district authority is in a process to return back the allotted land. Sri S.S. Singh requested PNB, Durgapur Zone to look into this issue on priority basis.

Sri T.L. Bhaduri, WBSRLM apprised the house that WBSRLM is maintaining a close liaison with district authorities on land allotment and encroachment issues. Sri S.S. Singh requested him to follow up these issues again with District authorities under intimation to NACER, Institutional Finance department, GowB and SLBC. He also requested member banks to expedite the process of starting construction work of RSETIs where land have already been provided.

(Action point 2: WBSRLM & sponsor banks)

4. Setting up of new RSETIs in newly formed districts:

Sri Sanjay Kumar Vishwas, AGM, SBI appraised the house that they had requested Kalimpong & Paschim Bardhaman district authority for allotting suitable plot of land preferably one acre or any government building for setting up of RSETI. Sri T.L. Bhaduri requested SBI to find suitable rented premises by their own and start functioning of the RSETIs. Smt Binoti informed the house that they had sent the proposal of opening new RSETI at Alipurduar to NACER for getting necessary approval from MoRD. Sri Dhruba Ghosh, Senior Manager also informed that the proposal of opening new RSETI at Jhargram had been sent to the Corporate office for getting necessary approval.

(Action point 3: SBI, PNB & Central Bank of India)

5. Pending status of claim made by RSETIs:

Sri S. K. Nandi informed the house that a huge claim, towards training to rural poors, of different RSETIs was lying pending at WBSRLM. He requested WBSRLM to clear the pendency at the earliest and to intimate the claim settlement to concerned RSETI Director along with Nodal officer for better reconciliation. Sri T.L. Bhaduri apprised the house that as the funds received from GOI, MoRD had already been exhausted, the reimbursement could not be made in some cases. He requested all the Banks to submit duplicate sets of pending claim related to previous year, if any, within 07th July 2022 to WBSRLM. He also requested Nodal Officers of RSETIs of Sponsor Banks to verify from the Bank account and send acknowledgement of receipt of payment within the 07th July 2022 to enable WBSRLM to submit the same to MoRD for further release of funds. Sri S. K. Nandi requested WBSRLM to convene quarterly meeting at their office regularly to sort out different issues pertaining to functioning of RSETIs.

(Action point 4: WBSRLM & Sponsor Bank)

There being no other points of discussion, the meeting ended with vote of thanks to the chair & the participants by Sri S.S. Singh.
