Re: Minutes of the Steering Committee meeting on 31.05.2022

The quarterly meeting of the SLBC Steering Committee was held today virtually to fix up the agendas for the ensuing 156th SLBC meeting. The meeting was attended by Mr. Mashir Alam, Secretary, Department of Agriculture, GoWB; Sri Manas Dhar, Special Secretary & Director, Institutional Finance, Finance Department, GoWB; Sri Sandip Nag, Joint director, Department of Textiles, GoWB; Sri R. K. Middya, Joint Director, MSME (PS), GoWB; Sri Kamalesh Kumar, GM, NABARD; Sri Provin Kami, DGM, RBI and representatives of major member Banks.

The Meeting began with a warm welcome note delivered by Sri Sakshi Gopal Saha, General Manager, SLBC West Bengal who was accompanied by Sri Shio Shankar Singh, recently joined as GM SLBC. He appraised the house that the 156th SLBC Meeting for reviewing the business position ending on March' 2022 has been scheduled to be held on 07.06.2022. He briefly enumerated the proposed agendas for the aforesaid SLBC meeting and invited the participants to give their valuable inputs/ suggestions for having a fruitful interaction on the proposed agenda points.

The major points of discussions along with the action points emerged during the Steering Committee Meeting are enumerated below:

- Sri Manas Dhar requested to shift the agenda of "Review of restructuring of loans in natural calamity affected districts in the State, if any" after the agenda of "Deployment of Credit in Agriculture". Again, he requested to highlight the performance under Matsya Jeebi Credit Card in KCC (KCC-crop cultivation, KCC-AH & KCC-Fishery). The point was accepted by the members of the house and was noted for compliance by SLBC accordingly.
- Sri Kamalesh Kumar, General Manager, NABARD requested to include the benefits of availing grant assistance from Financial Inclusion Fund by member banks for conducting Financial Literacy camps in different locations. Sri S. G. Saha informed the house that same will be discussed under broad agenda of "Financial Literacy Camps & Awareness Drive".
- Sri Kamalesh Kumar also requested for inclusion of agendas on (i) Credit Guarantee Fund (CGF) under Central Sector Scheme on 10000 FPO promotion & AIF Scheme and (ii) Completion of Pre PLP meetings in all districts for the FY 2023-24. Sri S. G. Saha acknowledged the point and informed the house that agenda on CGF on FPO promotion and AIF scheme will be discussed under "Review of progress under Agriculture Infrastructure Fund". He also narrated that completion of Pre PLP meetings by all LDMs is a separate issue and will be taken care of separately. Hence it is not required to be included in the proposed agendas.
- Sri Mashir Alam, Secretary, Department of Agriculture, GoWB requested all member banks to take part in AIF and to focus in KCC sector to boost agriculture portfolio of the state. Sri Sandip Nag, Joint director, Department of Textiles, GoWB requested member banks to dispose of all pending proposals

proposals under Artisan Credit Card and Weavers Credit Card schemes at the earliest. Sri M. Dhar highlighted that these issues will be reviewed in ensuing SLBC meeting.

Sri Provin Kami, DGM, RBI highlighted that the points discussed are to incorporated in final agenda and rest of the agendas are in line with the stipulated guidelines.

All the points were noted by SLBC for ensuring compliance. Member banks also accepted the views/ suggestions emerged from the meeting that to be discussed in the ensuing 156th SLBC meeting.

After having fruitful interactions amongst the participants, the Final Agenda Items and its sequence as well were finalized for discussion in the ensuing 156th SLBC meeting and getting confirmation from the participants, Sri Shio Shankar Singh, GM, SLBC described the final agenda items as follows:
