Re: Minutes of the SLBC Sub-Committee meeting on RSETI held on 10.12.2021.

A meeting on SLBC Sub-Committee on RSETI was convened on 10.12.2021, to review the functioning & performance of the 19 RSETIs in the state as on 30.09.2021. The meeting was participated through VC by Smt. Anwita D. Surin, DGM, NABARD, Sri Sudip Bhattacharjee, AGM, RBI, Sri Swapan Kr. Nandi, State Director for RSETIs and other dignitaries of line department and representatives of member Banks.

The Meeting began with a warm welcome note delivered by Sri Sakshi Gopal Saha, General Manager, SLBC West Bengal. The major points of discussions along with the action points emerged during the sub-committee meeting are as given below:-

1. Achievement under Annual Action Plan 2020-21:

Sri Swapan Kr. Nandi, SDR informed the house that initially cumulative AAP target for FY 2021-22 of 19 RSETIs was to conduct 428 no of training programmes covering 11695 no of candidates. Later, due to Covid-19 pandemic, the AAP target is revised and going to be approved by NACER very shortly. As on 30.09.2021, all RSETIs have so far trained 1124 no of candidates conducting 50 no training programmes, thus achieving 11.68% & 9.61% of the initial AAP target in terms of no of programmes & no of trainees respectively. 2nd wave of COVID 19 pandemic in the first quarter of FY 2021-22 have affected in conducting of the training programmes a lot. Once the revised target is approved, the achievement % will also be increased. Sri Sudip Bhattacharjee, AGM, RBI requested that the RSETIs should strive their best to achieve 100% of their revised target by the end of FY 2021-22. Sri S. K. Nandi assured the same.

Sri Sakshi Gopal Saha, General Manager, SLBC West Bengal also appraised the house that cumulative Settlement & Credit linkage as on 30.09.2021 stood at 73.69% & 60.26% respectively, which appears to be quite satisfactory with reference to national average.

(Action point 1: All RSETIs)

3. Status of Land Allotment & construction of RSETI building as well:

Sri S. K. Nandi highlighted that, as requested by WBSRLM, Central Bank of India have agreed to shift their RSETI from existing place at Siliguri Municipality to Darjeeling GTA in the Darjeeling district. But, while placing the same in the last DLRAC meeting, Hon'ble District Magistrate and Chairman of the committee have opposed the decision of such shifting. Sri Vikas Kumar, AGM, CBI sought necessary direction in this regard. Considering high importance of this matter, Sri S. G. Saha requested WBSRLM to take up the matter with concerned District Magistrate and to inform the decision to CBI for necessary compliance. Sri V. Kumar agreed upon it and informed the house that they will abide by the instruction.

(Action point 2: WBSRLM)



Sri T.L.Bhaduri, Consultant (Banking & FI) informed that, RSETIs at Jalpaiguri, Uttar Dinajpur & Purba Medinipur have been allotted land long back for construction of building. He requested sponsor banks of these RSETIs to take appropriate action for surrounding the land by a wall to minimize the possibility of encroachment of land and to start necessary construction work thereon at the earliest. He also informed that there is no further progress in land allotment by Govt. of West Bengal. However, WBSRLM is in close follow up with different district authorities for early resolution of pending cases. Sri S. K. Nandi requested WBSRLM to take up the issue of vacating encroachment from the allotted land for RSETI Coochbehar with concerned authority. Sri S.G. Saha requested him to send a RSETI wise updated land allotment status report to SLBC and to keep in close touch with concerned departments.

(Action point 3: WBSRLM & sponsor banks)

4. Setting up of new RSETIs in newly formed districts:

Sri Sinku Parira, AGM, SBI appraised the house that they have requested Kalimpong & Paschim Bardhaman district authority for allotting suitable plot of land preferably one acre or any government building for setting up of RSETI. Sri S. K. Nandi requested SBI to explore the possibility for starting RSETIs in rented buildings in these two districts. Sri S.K. Nandi also requested CBI & PNB to follow same in Alipurduar & Jhargram district respectively.

(Action point 4: SBI, PNB & Central Bank of India)


5. Pending status of claim made by RSETIs:

Sri S. K. Nandi informed the house that a huge claim, towards training to rural poor, of different RSETIs is lying pending at WBSRLM. He requested WBSRLM to clear the pendency at the earliest. He also requested WBSRLM to intimate the claim settlement to concerned RSETI Director also along with Nodal officer for better reconciliation. Sri T.L.Bhaduri appraised that a major portion of amount have also been cleared from the end of WBSRLM. Sri S.G. Saha requested all nodal officers of RSETIs to prepare a RSETI wise exhaustive list of claims sent to WBSRLM & claims so far settled on an urgent basis and to share with Sri S. K. Nandi for necessary reconciliation with WBSRLM.

Sri S. K. Nandi requested WBSRLM to submit RSETI wise pending claim position in all the Sub-Committee meetings of SLBC henceforth for better understanding of pending claim position. It will also help to reconcile the pending claim position with the sponsor banks.

(Action point 5: WBSRLM & Sponsor Bank)

There being no other points of discussion, the meeting ended with vote of thanks to the chair & the participants by Sri S.G. Saha.
