Re: Minutes of the Steering Committee meeting on 15.12.2021

The quarterly meeting of the SLBC Steering Committee was held at 12:30 P.M on 15.12.2021 virtually to fix up the agendas for the 154th SLBC meeting. The meeting was attended by Sri Manas Dhar, Special Secretary & Director, Institutional Finance, Finance Department, GoWB; Sri Kamalesh Kumar, GM, NABARD; Sri Sudip Bhattacharyya, AGM, RBI and representatives of major member Banks.

The Meeting began with a warm welcome note delivered by Sri Sakshi Gopal Saha, General Manager, SLBC West Bengal. He appraised the house that the 154th SLBC Meeting for reviewing the business position ending on September, 2021 has been scheduled to be held on 28.12.2021. He briefly enumerated the proposed agendas for the above said SLBC meeting and requested the house for further suggestion/discussion on the action points accordingly.

The major points of discussions along with the action points emerged during the Steering Committee Meeting are as given below:

- Sri Sudip Bhattacharyya requested for inclusion of review of working of Special Sub-Committees of the DCC (SSC) in the Districts with CD Ratio below 40%. Sri S.G. Saha highlighted that the issue is discussed in SLBC meetings in the agenda of CD Ratio & review of Districts with CD ratio below 40%. Sri M. Dhar Special Secretary & Director, Institutional Finance, Finance Department, GoWB suggested that a combined agenda of CD Ratio & review of Districts with CD Ratio below 40% along with corrective measures taken in Special Sub-Committees of the DCC (SSC) may be placed.
- Sri Manas Dhar, requested for keeping 'Progress in JLG Finance' as a separate agenda.
- Sri S. Bhattacharyya requested to keep an agenda on Review of inclusion of Financial Education in the School Curriculum, financial literacy initiatives by banks (particularly digital financial literacy). Sri M. Dhar appraised that this agenda is being discussed in the broad agenda of Financial Literacy Camps & Awareness Drive. However, keeping in view of the points suggested by Sri S. Bhattacharyya, an agenda of Financial Literacy Camps & Awareness Drive and review of status of Financial Education in School to be kept in the ensuing SLBC meeting. Sri Kamalesh Kumar, GM, NABARD appraised the house that many schemes have been evolved under Financial Inclusion Fund and it will be elaborately discussed in SLBC meeting.
- > Sri S. Bhattacharyya highlighted that bank wise progress under DMS as Revamped Lead Bank Scheme to be placed in the meeting, so that defaulting banks may be taken care of by RBI.
- > Sri S. Bhattacharyya also requested for inserting the agenda of review of restructuring of loans in natural calamity affected districts in the State, if any. Sri S. G Saha noted the same.
- Member banks also accepted the views/ suggestions emerged from the meeting that to be discussed in the ensuing 154th SLBC meeting.
