Re: Minutes of the Special SLBC Sub-Committee meeting on SHG & SE held on 02.01.2021.

One special meeting of SLBC was convened on 02.01.2021, to review the progress made under SHG as well as to fix a road map towards achieving ACP target under SHG-SE for the FY 2020-21, as advised by Dr. Amit Mitra, Hon'ble Finance Minister, GoWB in the 150th SLBC meeting held on 29.12.2020. The meeting was participated through VC by Dr. M.V. Rao, ACS, Panchayat & Rural Development and Co-operation, Smt. Barnali Biswas, Secretary, SHG & SE, Smt. Kuhuk Bhusan, SMD & CEO, WBSRLM, Mr. Narayan Sarkar, MD, WBSCL, Sri Manas Dhar, Director, Institutional Finance, GoWB; Sri J.P. Tirkey, AGM, RBI and other dignitaries of line departments and representatives of major member Banks.

The Meeting began with a warm welcome note delivered by Sri S. G. Saha, General Manager, SLBC West Bengal and he appreciated the cumulative effort of banks along with the extended support of Line Department of GoWB in implementing various schemes under this prevailing pandemic due to COVID-19.

The major points of discussions along with the action points emerged during the sub-committee meeting are as given below:-

- Sri M. Dhar expressed his concern over non-acceptance of IBA approved common loan application form for SHG by several Branches of PNB causing hardships to the SHGs. He requested SLBC to take a note of that and to instruct the PNB along with other member Banks suitably to address such issue immediately. Sri Dhar also informed the house that the disbursement figure is 51.27% till December 2020 against the total disbursement target and he expressed his disappointment regarding this poor disbursement figure by the member Banks. He specially mentioned to the low disbursement by the e-UBI branches in respect of the total PNB 2.0 figure.

(Action point 1: Member Banks & PNB)

- In this regard Sri S. G. Saha stated that an instruction has already been forwarded to all the concerned branches to accept IBA approved common SHG loan application form and necessary actions are also being implemented by the Branch Heads to increase the disbursement figure.
- Dr. M.V Rao highlighted an issue regarding the data feeding in portal by the member Banks. He requested all the Banks to feed proper sanctioned data in the portal so that the actual performance can reflect in the portal. He requested the Bank to complete this pending data updating in the portal by 15th of January, 2021 without further delay.

(Action point 2: Member Banks)

- Smt K. Bhusan added in this regard that there are few Banks where the updating in the portal has not been taking place properly and she pointed the banks viz. SBI, UCO Bank and Allahabad Bank where major portion is pending for updating.

(Action point 3: Member Bank)

- Dr. M. V. Rao requested all the Member Banks to instruct their branches to accept all new SHG NRLM loan applications by 15th Jan, 2021 for further sanction of the proposals within this current financial year. He also requested DRDC to further complete the sponsoring of fresh cases by 15th January' 2021 to different branches.

(Action point 4: Member Banks & Line departments)

- Sri S. G. Saha requested WBSRLM to share the bank branch wise beneficiary details under SHG NRLM for better monitoring & follow up for quick disposal of the applications.

(Action point 5: WBSRLM)

- Mrs. S Sen spoke on the initiatives taken by SUDA in promoting the self-employment avenues in urban localities and requested the Banks to dispose of the pending proposals for the SHGs and the individuals under NULM on an urgent basis.

(Action point 6: Member Banks)

- Sri N Sarkar requested the Banks to dispose of all the eligible sponsored case under SVSKP from the year 2018 to 2020 on priority basis along with subsidy. He requested the member Banks to return the subsidy lying pending with different Bank branches pertaining to FY 2002-03 to 2016-17 within 31.12.2020.

(Action point 7: Member Banks)

- Sri S.G.Saha informed the house that out of Rs.88 crore pending subsidy reported by WBSCL, member Banks have already disbursed 38.78 Cr. And the rest 49.55 Cr. subsidy would be disposed of by 31.01.2021.

(Action point 8: Member Banks)

- Smt. B. Biswas also requested all the member banks to strictly follow the deadline of 31.01.2021 for bank branch wise reconciliation of pending SVSKP subsidy without fail.

(Action point 9: Member Banks)

The meeting ended with vote of thanks to the chair & the participants by Sri S. G. Saha.
