NOTIFICATION

Whereas it appears from the report prepared and submitted by the Deputy Director of Agriculture (Admn.), Murshidabad vide his Memo. No.2336/1(7) dated 16.05.19 & 2465/1(6) Dated 27.05.19 on the basis of Block Level Reports , 23 (Twenty Three) No. of Mouzas having 33 % and above crop damaged area covering 2 (Two) Blocks Nabagram and Hariharpara of Murshidabad District as mentioned in the list enclosed under Annexure A have been adversely affected due to Cyclone Fani & post Fani rain water accumulation and heavy rainfall with Hailstorm occurred on 03.05.2019 & 04.05.2019 and 15.05.2019 respectively.

And Whereas a detailed resurvey was made to assess the extent of damage caused to standing crops Boro Paddy i.e. Summer Rice & Sesame (Til) in the Cyclone Fani affected 16 Mouzas of Nabagram Block and Jute in the Hailstorm affected 7 Mouzas of Hariharpara Block by the Officers of the Agriculture Department after the natural calamity had occurred.

In view of the above, I, **Shri Jagadish Prasad Meena, IAS**, do hereby declare and notify 23 (Twenty Three) Mouzas of 2 (Two) Blocks of Murshidabad District as listed hereunder vide Annexure A having more than 33 % damaged cropped area due to Cyclone Fani and Hailstorm affected as per norms of SDRF / NDRF for further necessary action.
