NOTIFICATION-AMPHAN

Whereas it appears from the final crop damage report prepared and submitted by the Deputy Director of Agriculture(Admn.), Murshidabad vide his Memo. No.1689 dated 25.05.2020 on the basis of Block & Sub-Division level reports received, 542 (Five Hundred Forty Two) Nos. of Mouzas having above 33 % crop damaged area covering 8(Eight) Block namely Berhampore & Beldanga-II under Berhampore Sadar Sub-Division , Nabagram of Lalbagh Sub-Division, Kandi,Khargram,Burwan of kandi Sub-Division and Raghunathganj-II , Samserganj of Jangipur Sub-Division of Murshidabad District as mentioned in the list enclosed in Annexure-A have been adversely affected due to Cyclonic Storm-AMPHAN occurred on 20.05.2020 & 21.05.2020 which resulted in crop damage above 33 % to standing Boro Paddy,Jute, Sesame (Til) ,Summer Moong,Summer Maize,Summer Vegetables and Fruit & Plantation(Orchards).

And whereas a detailed survey was conducted to assess the extent of damage caused to standing crops Boro Paddy,Jute, Sesame (Til) ,Summer Moong,Summer Maize,Summer Vegetables and Fruit & Plantation(Orchards) by the officers of the Agriculture Department working at Block, Sub-Division & District after the Cyclonic Storm-AMPHAN had occurred.

In view of the above, I, **Shri Jagadish Prasad Meena, IAS**, do hereby declare and notify 542 (Five Hundred Forty Two) No. of Mouzas of Berhampore, Beldanga-II,Nabagram,Kandi,Khargram,Burwan,Raghunathganj-II, & Samserganj Block of Murshidabad District as listed hereunder vide Annexure A having more than 33 % damaged cropped area due to Cyclonic Storm-AMPHAN as per norms of SDRF / NDRF for further necessary action.
